Dear Mr. Elio Sgreccia and The Congregation for the Doctrine of Faith,

I am in receipt of The Congregation for the Doctrine Of Faith's now famous letter to Debra Vinnedge, here in the U.S.A., regarding vaccinations and the morality of using vaccinations derived from cell lines of aborted fetuses. We Catholics here in the United States, who believe that the Vatican and our Holy Father still govern our Church, continually and unwaveringly look to Rome for our answers to so many of the spiritual, moral and even the mundane, daily issues with which we are confronted. As my Catholic upbringing dictates to me always, you cannot separate your business/political/ professional lives from your moral/spiritual persona or comportment. Sadly and ominously, that is not the consensus here in the US, and as evidenced by world events, probably not the case in most of our world today. However, I can only speak about conditions in America, with any degree of certainty.

As a fifty-five year old man, I have faltered throughout my life, as all do. However, the *doctrine of my faith*, the foundation of my life, (i.e. you are either **with** Christ...or you are **without** Him!) consistently brings me back Home. Being in Christ has always meant to me, that regardless of the circumstances or the seemingly, insurmountable odds, one must always seek the Truth, defend it, promulgate it and preserve it for everyone, for all time. In the words of Pope St. Felix III, "Not to defend Truth...is to suppress it". In today's world, Truth, more often than not, is adulterated, *tainted*, by euphemisms, semantics, "political correctness" and blatant lies posing as truths, left to be discerned, researched and refuted by the honest men and women already inundated by our ever-increasing daily travails. Indeed, here in the US, it has been a long-time, unwritten *law* to not talk about religion and politics in any formal setting; at dinner parties, in the workplace, in the classroom, and even from our Pulpits! That's right! Many of our Priests, shepherds of God's flock, refuse to "get involved". Of course, occasionally we hear a few grumblings around election time about the evils of abortion, homosexuality, divorce, etc. But were it not for a handful of truly dedicated Priests and lay people, the issues stay muted. To think that the abhorrent **sin** of abortion would not be in every Priest's sermon, at least every Sunday, is as sinful as the abortion itself...much like the reasoning concerning vaccinations with aborted fetal tissue cells and the degrees of immorality therein as posited by The Congregation for the Doctrine of Faith. As has become the rule rather than the exception, our Priests, our Catholic Church in America do not want to make waves, at least not high ones, for fear of alienating their

parishioners and offending the *politicos*. This is just one example of what is going on in our Catholic Church here in America. Judging from Your lengthy and no doubt, sincere “answer” to Mrs. Vinnedge regarding vaccinations, regretfully, but with the utmost respect, I perceive that that very same “virus of political correctness” may be migrating to our leaders in Rome. Your very own assertion that “As there were no formal guidelines by the magisterium concerning that topic...”, begs the question, “After fifty years of desecrating billions of fellow human beings with these *tainted* vaccinations, why *doesn’t* the magisterium have formal guidelines concerning this topic?” Certainly, we cannot expect our Church fathers to know everything-about-everything that is going on in our increasingly more complex and technologically advancing world. As such, You must defer to civil authorities more and more. Unfortunately, the consistent practice of yielding to civil authority has become so common in our Church, regardless of the subject matter, that now the faithful, themselves, are beginning to regard the Church in a secondary, less authoritative role in our lives. The civil authorities in our fundamentally Christian nation now view our Church, and our allegiance to its precepts, condescendingly and with the arrogant tolerance reserved for a recalcitrant or simple-minded child at the dinner table. We have allowed ourselves to become insignificant by our very own complacency and faltering convictions. Our Church, our doctrines, indeed no less than our God and His Son are responsible for *all* of our laws of morality, ethics, civilization and governance. We must demand the respect for His place at the head of humanity’s table, but at the same time prove that we are worthy to demand on His behalf.

Re: Morality, Efficacy, Safety, Validity and Legitimacy of Universal Vaccinations

I am not a professional vaccinologist, virologist, epidemiologist, research scientist, doctor, nurse, health official or statistician (or professional writer). I reserve those areas of expertise for the experts. As a Catholic of average intelligence and more willing than most to profess my beliefs and defend them and those who may not be so-inclined or capable of doing the same, I applaud Your thorough, yet overdue support of those concerned parents seeking a religious exemption in the matter of vaccinating our children with *tainted* vaccines. Obviously, Your moral premise is flawlessly developed and unequivocal. I would have expected nothing less from the one, true authority on Morality; indeed, why I am ever so “humbly” proud to be a Catholic. You perspicaciously chronicled certain vaccines and their shocking origins; but something is painfully absent. No fetus artificially aborts itself. No vaccine manufactures itself. No vaccine injects itself into the arm or buttocks of an innocent child. No newspaper article, press release, book, study report or laboratory report extolling the virtues of this practice and its practitioners...writes itself. As usual, the perpetrators are ignored. The guilty remain nameless. The evil acts go unpunished! Undeniably, as leaders of the Christian world, Your position should be one of diplomacy and temperance. However, and especially in matters of such gravity, candor is obligatory.

Other than the actual act of creating the abortion, I can think of no other act more detestable than to recreate that evil and memorialize it by making it a part of the body and demonically scarring the uncorrupted souls of countless billions, made in our Father’s own image. Shame on us all! The admission and public pronouncement of the use of aborted fetus tissue cells just magnifies that evil and, with the depravity of Satan, revisits the Crucifixion of our Lord as we stand by and watch! No good can be derived from an act of such evil. What

kind of men are capable of such malice? After their “pact with Satan”, what can we expect from such men? With regards to these vaccines alone, for 50 years we have accepted this wickedness. Are we to believe that these very same minions of Satan suddenly developed integrity, decency or morality? I expect not! With avarice, malevolence, pure evil and blackened hearts, can we now expect that they will simply destroy, perhaps, billions of dollars worth of stockpiled vaccines and begin the process of research and trial-and-error for another 5-10 years to create new, *untainted* vaccines just to placate that obnoxious child seated at *their* table? Of course not! I contend that they will lie and cheat and deceive to quiet those vocal *few* who oppose this evil. How difficult will it be for them to change labels, falsify reports, fabricate press releases, magazine articles or lab results when they are capable of the most heinous crimes. The malfeasance will continue unabated. Are we to believe that making a “conscientious objection” to such vile acts will accomplish anything? How naïve can we be? They continue to kill babies...by the millions...**every** year!

No good **does** come from such acts of evil-not even ostensibly. Despite Your many assertions as to their efficacy, no proof of immunity attributable to universal vaccinations actually exists. The epidemiological statistics often cited by the proponents of vaccinations are meaningless and grossly minimized due to the **voluntary** nature of the participation of doctors and health officials in the reporting of any adverse events. How can we possibly trust any information provided by the very men responsible for the genocide of innocent human beings? As a matter of fact, many of the outbreaks referred to in Your work and many more that Your sources may not have mentioned, actually occurred in region-after-region of high rates of “vaccine-created” immunity. Outbreaks have occurred in communities of 95+% vaccination. Naturally, their answer is, and always would be, to vaccinate more. Quite the opposite is true. Medically and scientifically, vaccinating and creating artificial immunity is **ineffective** and often creates a greater propensity to contract the disease in the wild, with more violent reactions and more collateral damage, *especially for those already vaccinated!*. The very theory of vaccinating, and it is only a theory, implies that the virus selected and its adjuvants will cause a perfectly measured immune response and confer permanent immunity on the recipient. Adjuvants are those substances that are added to a vaccine mixture to enhance the immune response. Chemical substances, micro-organisms, oil emulsions together with mercury, aluminum and formaldehyde are just a few of the additives in the vaccine amalgam. Every aspect of manufacturing vaccines and vaccinating is unpredictable and impossible to control. The variety of immune responses varies with as many recipients. To presuppose a predictable response is as ludicrous as it is deadly. This is a veritable tragedy waiting to happen. Again, the limitless arrogance of the planners is matched only by their maliciousness.

The process of building immunity is cumulative and necessarily involves being exposed to antigens, experiencing dis-ease, and allowing the body’s natural defense mechanisms to “learn”. When our bodies develop *natural* immunity it is permanent. No “booster shots” are necessary. Proper nutrition builds a healthy body and provides all the raw materials to ensure a viable defense system. If a body is already unhealthy and in a weakened state, and we bombard it with antigens, and irritants that *we* have arbitrarily determined are appropriate, how hard is it to imagine that unnatural, unpredictable and un-Godly things will happen? And they do! I will expound later. How arrogant is it for these evil planners to think they can improve on God’s

perfect plan? Of course, it becomes more evident with every gambit; this can only be achieved by their requisite *removal* of God from the equation.

For many of the viruses mankind has encountered in his existence, he has been successful in building sufficient, natural immunity to almost complete eradication. Here in the US alone we have witnessed complete eradication of smallpox, scarlet fever, cholera and natural declines of measles, rubella, mumps and polio, to name a few, *without the "aid" of vaccines*. General improvements in sanitation, advances in hygiene, knowledge of sound nutrition and the very nature of disease, have all contributed to a favorable environment for understanding and dealing with the disposition of infectious disease through natural immunity and conferring that immunity to our offspring via the mother's naturally acquired immunity. As the child matures, so, too does his/her immunological competence. Much of the fear and mystery of disease has been eradicated, except for the carefully orchestrated and devious media campaigns designed to recreate the "terror" and the very fear our *honorable* science has served to eliminate. Media blitzes are designed to confound and create the panic and the resultant frenzy needed to sell the unsuspecting public, ineffective and potentially deadly vaccinations. There are more than sufficient sources of information to corroborate all I have presented here, and much more. Some of the thousands of sources available are cited below.

More specifically, and with regards to Your explanations of Rubella, and the statistics quoted, please realize that You are quoting sources that have a strong vested interest in the proliferation of vaccinations, the same, very honorable men responsible for the elimination of hundreds of millions of babies worldwide. You can see that their solutions invariably point to increased vaccination. With regards to Rubella, what Your sources failed to mention was that since 1930, an entire generation of Americans had already been subjected to a destructive Pertussis vaccine and previously and continually smallpox vaccines. In the decade preceding the "severe Rubella epidemic" of 1964, the American public had been bombarded, and further "weakened", by two destructive vaccines for polio. In 1963, yet another vaccine was *forced* on the American people, this time for Measles; ironically, at a time when Measles was naturally and rapidly becoming inconsequential. Vaccinations were becoming "big business"; too big for the schemers to ignore and certainly much more important for them than the havoc they were about to unleash on those poor souls obediently delivering their newborns to "slaughter" in the name of "prevention".

Your conclusions calling for the "systematic vaccination against such a sickness" as Rubella or any of the so-called contagious diseases, is not only medically unsound, it is also fundamentally flawed; it is obviously insufficiently researched and ultimately may be more damaging than the vaccinations themselves. The results You cited, were obviously published by the very vaccine manufacturers and promoters, and are blatantly untrue. As the spiritual heartbeat of a billion Catholics and collaterally, stewards of billions more, it is irresponsible and dangerous of "The Congregation" to blindly support unsubstantiated claims. When considering the real facts, it is unconscionable to support such an agenda-under any circumstances! An agenda promoted by those who are morally, fundamentally and doctrinally opposed to everything You represent and we desperately need. Opposed to everything Good and Right and Just. Opposed to God, Himself!

Additionally, it is your contention that recombinant forms of the offending viruses or vaccines cultivated in animal tissue are a safe or acceptable alternative to the aborted fetal vaccines. Acceptable!? Safe!? I can only hope that this declaration, too, is based on insufficient knowledge. Consider the consequences! To think that adulterating the perfection reserved for God's Supreme Creation with animal cells, introduced directly into the bloodstream, is acceptable to the covenantal Guardians of that very Creation, defies reason. Not only is the medical reasoning unsound, and the efficacy falsified, but the science is bizarre and worthy of the same rejection as the use of aborted fetal cells. Briefly, let us consider the use of *recombinant* forms of the viruses. *Recombinant* sounds very erudite and scientific. How about men, evil men, playing **god** and genetically *re-engineering* the viruses we already have difficulty defending against in their **natural forms**. Viruses are God's creation as well. He would not have created anything we are not equipped to handle if we stick to His plan! When imperfect men, immoral men, try to perfect God's plan, is it too difficult to envision the results?

It is of particular interest to note the worship of half-man, half-animal by so many of the Pagan religions throughout history. Depictions of those menacing figures evoke fear and revulsion by the faithful. This practice of cultivating "cures" for man by using other, lesser life forms is repulsive and is nothing less than an assault on and insult to the Perfection and Supremacy of our Creator. Look around You. Has the adulteration of man's body been constructive?...or infinitely destructive? Can we expect the compounding of evil and Godless acts to exist without consequences? We here in America use the axiom that "the face is the mirror of the soul". I believe the converse is equally true, viz: the condition of our souls is exemplified by the condition of our bodies. Observe! Hospitals are full; we are in horrendous physical shape; gluttonously obese and chronically ill. We have abandoned God's formula for life; healthy bodies, healthy minds, healthy spirit...and Eternal Paradise as our destination. Instead, we have adopted man's approach. We now rely on science's solutions for the very problems it has created; drugs, psychotherapy, *recombinant viruses* and death, natural and unnatural, as the ultimate *escape*. By supporting these evil schemers at any level and in any small way, we are perpetuating the very same "Culture of Death" we so vehemently oppose!

In reality, the vaccinating of the world has been a complete failure. It is painfully obvious to me, but not surprising, that Your sources neglected to mention the veritable plagues that have befallen every country where the "American" answer to disease has been adopted, specifically vaccinations. Since their debut on the American scene, vaccines have been directly responsible for the deaths of countless, millions of innocent children and adults as well. Millions of families have been forced to endure unfathomable grief and suffering as they watch hopelessly as loved ones, particularly our innocent, trusting children drift away silently into eternal rest or are banished to a life of desolation, lost forever in a psychological limbo, more often than not, ravaged by chronic disease. Your sources, and those they serve, consistently refuse to acknowledge the mountains of irrefutable proof that vaccinations are the culprit, for fear of an equally massive surge of lawsuits and reprisals by the tormented, wrath-filled family members; as if monetary compensation could even begin to restore peace to their lives.

The pharmaceutical cartels in their infinite audacity, omnipotence and limitless finances, thanks to the various governments around the world and their compulsory vaccinations programs, continue to manipulate and fabricate statistics and publicity about their diabolical

scheme. Only the sincere and unyielding efforts of a chosen few are responsible for exposing this evil plan. Armed with Truth, undoubtedly guided and empowered by the Holy Spirit, and protected by legions of Angels, they work tirelessly to avenge, in most cases, the loss of one of their own and hopefully prevent more pain and suffering for others. There is nothing on this earth, save the Crucifixion of our Lord, that can possibly come close to the horror of seeing the lifeless arm of your beautiful, 29-day-old baby boy, Peter, hanging from his cradle, head laying in a pool of blood from ruptured vessels in his lungs as he struggled to get air through his tiny throat, closed shut from a severe allergic reaction to the vaccination he received just 36 hours before.

All the shocking statistics and evidence of the failure of our vaccination programs and the inaccuracy of the reporting of their efficacy can be found in thousands of books, articles, studies and, most compellingly, in the ever-increasing anecdotal testimonies of the families themselves. Anecdotal evidence is especially avoided by the medical/ pharmaceutical professionals. Those insiders who violate that *rule* are quickly chided or eliminated, altogether, from the inner circles. Is it not cold-blooded and sadistic madness to subject a newborn child to a barrage of up to 33 vaccinations during his first 2 years of life? Vaccinations mandated by our government! Imagine injecting some of the most toxic and offensive substances a human may ever encounter, certainly at least during childhood, into a totally defenseless, immuno-*in*competent, pristine, newborn little body. It defies all reason and decency. Consider: during a birth, delivery rooms, doctor's instruments, hands scrubbed and gloved, caps, gowns, shoes, masks...are all sterilized. The newborn infant is taken to a nursery, also sanitized, linens, bassinets all disinfected and spotless. Why? During the next 12 hours of his/her new life, a mixture of antigens and toxic adjuvants will be injected directly into his bloodstream; bypassing the natural, albeit immature, defense pathways; skin, nasal passages, mouth, mucous membranes, etc. Potent irritants, he may never encounter in his life, certainly not in his bloodstream, combined with the deadly, Hepatitis B virus. Incredible! Hepatitis A; Hepatitis B; Diphtheria, Tetanus and Pertussis(DTP); Haemophilus Influenzae b(Hib); Polio Virus(IPV); Pneumococcal Conjugate Virus(PCV7); Influenza; Measles, Mumps and Rubella(MMR); Pneumococcal Polysaccharide 23(PPV23); Varicella; and other vaccines and repeat doses and boosters...up to 33 in 2 years! This is utter madness. If these vaccines are so vital for life, "How has civilization been able to endure thousands of years of existence *without them?*"

Mercury is a known, thoroughly documented, devastating neurotoxin. Since 1930, it has been used extensively in most childhood vaccines, over-the-counter teething powder, antiseptics, and other cosmetic items. Since 1935 the destructive effects of mercury have been known! These same evil planners, and now their successors, are responsible for knowingly poisoning generations of our children! Is it not criminally naïve to expect men capable of such calculated, unimaginable depravity to "give us their word" that mercury or other lethal adjuvants **or** *aborted fetal cells*, will no longer be used? It wasn't until now, that *any* effort has been made to remove mercury from these lethal injections; and only after the tempest created by those unyielding crusaders, enduring ridicule, criticism, the lies and deceit of our medical/pharmaceutical/ governmental establishments, and still courageous enough to take on the challenge. Incomprehensibly, the very same government that mandates vaccinating our innocent children with lethal injections, *has not made the removal of mercury mandatory!*

The presence of toxic mercury is just one of the many aspects that render vaccines deadly and undesirable. I have described several consequences of vaccinating previously; more are painstakingly described in the literature referred to below. What I have not described so far are those myriad illnesses and conditions, that when evaluated scientifically, logically and anecdotally, are directly and causally related to vaccinations.

Caveat lector! What You, The Congregation for the Doctrine of Faith, must realize, is the state of our health affairs here in America, especially with regards to our children. Entire segments of our society are being systematically destroyed. Severe afflictions affecting almost every body system have been directly linked to vaccinations. Blood, lymphatic, digestive, cardiovascular, immune, neurological, respiratory and sensory systems are all being severely damaged. It is impractical to list *all* the diseases and syndromes created by vaccinations. Here are a few:

_____ As a direct result of vaccinations, our children now suffer to the tune of 1 in 166 with Autism alone! Autism was virtually non-existent before vaccinations began with the Pertussis vaccine, manufactured by the *Eli Lilly Co.*, in 1930.

_____ Encephalitis, subacute sclerosing panencephalitis, febrile and afebrile convulsions, seizures, ataxia, ocular palsies, anaphylaxis, angioneurotic edema, bronchial spasms, panniculitis, vasculitis, thrombocytopenia, lymphadenopathy, leukocytosis, pneumonitis, urticaria, deafness, otitis media, retinitis, optic neuritis, rash, fevers, dizziness, headaches.

_____ Guillain-Barré syndrome, Stevens-Johnson syndrome, erythema multiforme, Asperger's Syndrome, Reyes Syndrome, Palsy syndromes, Sudden Infant Death Syndrome, Juvenile Onset Diabetes, Atypical Measles, Meningitis, Immune System Suppression and the resultant Autoimmune Disorders, Atypical Mumps, Arthritis, Chronic Fatigue Syndrome.

_____ Chronic Inflammatory Bowel Disease and the many related diseases such as Crohn's Disease, Celiac Disease, and Irritable Bowel Syndrome.

_____ DEATH

As I stated previously, these are by no means *all* the afflictions caused by vaccinations. **Autism** itself can fill volumes with its many characteristics and variations. What is not listed here are the physical, psychological and, most damaging, spiritual diseases suffered by the loved ones of those "affected" by vaccinations. Impossible to comprehend or put into words, the caregivers silently persevere, only to utter when their own pain is too much to bear. Entire families and extended families, caused to suffer, mercilessly... *needlessly*.

As You can see now, armed with the *real* facts, to defend or support the practice of vaccinating, is to support its barbaric and inherently evil nature. To advocate their use is irresponsible...criminal!

Re: Vaccinations and Sterilization

As anyone who researches vaccinations eventually learns, the end result of their destruction is not isolated only to the individual, his family, his city, or even his country. The persistent, methodical, insidious planners, the medical/pharmaceutical/governmental cartel, have an even more ambitious scheme in mind; global control. Population Control (PC) has been an evil obsession since the Garden of Eden. The serpent, the apple, Adam and Eve; the analogy is

timeless and perfect here. The method for control has taken on many forms throughout history; the players, many disguises.

There are just so many aspects to the scheme for Population Control. Nevertheless, I will attempt to summarize it for our purposes here. It has been a perennial obsession of the many rulers of the world and has actually been accelerated and fortified more recently. As is always their modus operandi, the establishments of our world, especially the US government, via its foreign aid policies, and most other nations through the UN, as the WHO, UNICEF, UNFPA, actively and proudly support Population Control programs and their Zero Population Growth (ZPG) agendas. The super-rich and famous publicly and very proudly promote vigorous and, if necessary, violent control of the procreation of those “unfortunates” of the world whom they consider too ignorant and irresponsible to manage our most natural reason for living, procreation. If this were not evil enough voluntarily, their plans actually outline *mandatory* control: abortion, artificial contraception, infanticide, genocide and disease, natural and government-sponsored, under the guise of actually “preventing” disease. How? *Vaccinations, all by vaccinations!* By a slow, steady, unyielding, surreptitious psychological campaign of fear-of-nature and now a “bio-terror” of *contrived* foreign enemies, they have succeeded in queuing up the obedient, trusting “unfortunates” to achieve *herd-immunity*. *Herd-immunity and sheep; a perfect metaphor!*

Consider the facts. Now, in America alone, 1 in 100 boys will succumb to Autism as a result of our aggressive vaccination programs. What percentage of Autistics will be raising families even if they make it to adulthood? Add that to the rest of those killed or permanently injured by vaccinations, cleverly categorized as “other” ailments to confound us, and you now effectively achieve mortality and morbidity surpassing births. Do the math! **Abortions + contraception + deaths + inability to procreate = ZPG**. That’s here in America alone! Here, where we are supposed to be technologically advanced, better educated and with superior medical facilities, sanitary conditions and surpluses of fresh water and food supplies. Imagine in Africa, Asia, South America, where wars, genocide and none of the blessings we enjoy exist...ZPG! As if all this were not enough to sicken anyone, now contemplate the following: mass vaccination campaigns conducted by the WHO, to *test*, on living children, new *high-potency* vaccinations, 10 to 500 times normal potency, resulting in the **deaths of 1 in 6 babies** in Senegal, West Africa. Similar so-called “studies”, were conducted in Gambia, Togo and Guinea-Bissau, also in Africa. Mexico and Haiti were also subjected to these *humanitarian* programs devised by the beneficent UN. Apparently, the mass-murders committed in these Third World nations were not enough to stop our Population Control Masters at the UN. Not only did they rationalize these shocking results, with full knowledge of the high mortality rates, they continued to *test*, right here in the US! In the Los Angeles, California area, they falsified Measles outbreaks statistics to conduct and confine another “study” to predominantly Black and Hispanic communities. Thanks to an alert public official and community outrage, the program was stopped. Nevertheless, 1500 minority babies received Measles vaccines, also 10 to 500 times the potency of the normal vaccine. When and where does it end? Not there, not yet!

During the early 1990’s, our compassionate compadres at the UN, again, were responsible for delivering health and well-being to the “poor unfortunates” of the world. This time, more boldly, more wantonly, more revoltingly. The WHO was overseeing massive Tetanus vaccination campaigns in Nicaragua, Mexico and the Philippines. Briefly, Tetanus is a serious,

but preventable disease caused by a bacterium entering the body through an open wound. The target group just happened to be girls and women between the ages of 15-45 years old. (Nicaragua: girls and women 12-49 years old). Why not men, working strenuously in fields, on construction sites, fixing cars, digging ditches; or young boys playing in playgrounds, climbing trees, being boys? Because the caring, compassionate do-gooders at the UN were not necessarily interested in preventing disease or saving lives. It was uncovered that the Tetanus toxoid used in the vaccines was laced with HCG. HCG is human chorionic gonadotropin, the hormone secreted by the placenta after conception that triggers a cascade of events to prepare the uterus to accept the fertilized egg to sustain the pregnancy. Why put HCG in a Tetanus vaccine? It has no disease-fighting abilities. It does not assist the Tetanus toxoid in any way. Actually, it turns out that as the human body *learns* to attack the toxoid molecule, laced with HCG, during the immune response, the body recognizes the HCG as an “invader” as well, and develops an anti-HCG antibody. Since the body memorizes the immune response to this new Tetanus/HCG invader, future pregnancies will immediately be aborted, because the HCG will be eliminated before it reaches sufficient levels to start the uterine preparation. Naturally, when the sinister plot was discovered, the WHO denied the accusations and claimed the vaccines were **not** laced with HCG. Subsequent laboratory tests confirmed the presence of the HCG.
